





RAPTOR COUNTING, MANZANO MOUNTAINS ---Sunday, October 8th

Some of you have asked for Sunday trips. Here's the answer to your request!

Steve Hoffman, President, Western Foundation for Raptor Research, has invited CNMAS members to visit the fall count in the Manzanos. This trip will Expect see last. a11 dav. to Sharp-shinned, Coopers, Redtailed, Golden Eagles, Merlins, and perhaps Ferruginous hawks and Peregrine Falcons!

This trip will not be a hard climb like the spring count in the Sandias. We will drive to within 3/4 mile of the site and walk the rest of the way on a fairly level trail.

Meet at 8:30 a.m., Four Hills Shopping Center, Central and Tramway, near Baskin Robbins, along Central Avenue. East mountain residents meet the group at the Forest Service Ranger Station on S. HWY 14 at 9:00 a.m.

Wear warm clothing as the elevation is 9,000 feet. Bring lunch and water to last the day. Also, don't forget bird guides and binoculars.


"BIRD DAZE" ---Saturday, October 7th

1989 NEW MEXICO AUDUBON CONFERENCE --Friday through Sunday, October 13th -15th

The 1989 New Mexico Audubon Conference is being held at the Tres Rios Christian Growth Center, located south of Carlsbad, New Mexico. This quiet, secluded site is on the banks of the Black River and nearby to many birding spots. To reach the Center, drive south 13.4 miles from the intersection of US 285-US 62-180. Then turn east on state highway 396 for 4.4 miles. Check-in at the conference will begin at 4:00 p.m. on Friday, 13 October.

The 337 acres surrounding the Center provide activities for all. A nature trail runs through the area and there are nature activities manv other and interesting localities to visit nearby, including Carlsbad Caverns and Living Desert State Park. Field trips are scheduled for Saturday and Sunday mornings. Special speakers are scheduled for Saturday afternoon and some free time is scheduled for Saturday evening. 
2ND ANNUAL BOSQUE DEL APACHE AND SOCORRO FIESTA ---Saturday and Sunday, November 18th -19th

In case you missed this Fiesta last year, you now have a second chance to learn more about the endangered Socorro isopods as well as birds and other wildlife at the Bosque del Apache. (For more information on the Socorro isopods, see the article in this issue of the **Burrowing Owl)**.

Most activities will occur around the Socorro plaza and the Socorro Opera House, which has been restored. On exhibit will be wildlife art by well-known regional artists.

The wintering birds should be arriving at the Bosque by mid-November, and some fall migrants should still be around. The geese and cranes put on a spectacular display at sunset when they fly into the refuge to roost for the night.

ISOPODS WILL HAVE NEW HOME ---Wildlife News

Socorro, NM, June 22, 1989. Work started this week on a facility to house an additional population of the state and federally endangered Socorro isopod, an aquatic relative of the sowbug or pillbug. The facility is being built below Sedillo Spring, a thermal spring west of Socorro, said Charles Painter, endangered species biologist with the Department of Game and Fish.

Sedillo Spring is the only area where the Socorro isopod is known to occur in the wild, although a captive population exists at the University of New Mexico. The new facility, on an acre of land donated to the Department of Game and Fish by the City of Socorro, will contain eight small concrete tanks to hold the water at between 75 and 95 degrees Fahrenheit, the ideal temperature range for the crustacean.

Water from Socorro's water supply from Sedillo Spring will be diverted into the concrete tanks. which will have four-inch-thick walls. The tanks, four feet long by two feed in width and depth. will be placed on an incline with connecting pipes. The incline will be slight enough to allow the isopods to move between the ponds through the pipes. The pipes will be buried to conserve the heat of the water as it continues to the lower ponds, Painter said.

The facility is being build so that up to half the ponds can be removed from use at any time. This will allow for cleaning, repairs, and other servicing. Water that has cooled and passed through the ponds will flow into a sand-covered leach field below the ponds.

When the facility is completed, between 1,000 and 1,500 Socorro isopods from the University of New Mexico population will be moved to the tanks.

The facility is being built with federal Endangered Species Act and Share with Wildlife funds at a cost of \$28,875. Share with Wildlife funds are monies donated by taxpayers from their New Mexico income tax refunds. The fund was started in 1982 to allow people to contribute all or a portion of their refunds directly to the Department of Fish and Wildlife for wildlife conservation.

A six-foot chain link fence topped with three strands of barbed wire will be constructed around the one-acre site. In addition, a six-foot chain link fence will surround the tanks. October - November 1989

PREPARING FOR THE GREAT INVASION (BUT NO "CAWS" FOR ALARM)! --Bill Willard

It's that time of year again for the winged invasion of Albuquerque! The mass invasion of crows, that is. From the end of September through mid-March, thousands of American Crows (Corvus brachyrhynchos) make the bosque along the Rio Grande their winter residence.


For several years, I have been studying our wintering crow population. Until recently I focused on happenings at their communal roost and the primary foraging sites (mainly the city dump). This year I will concentrate on other aspects of the crow's workday. To do this, I will need some help because my eyes cannot cover the entire city effectively.

What I am asking for is simply this--whenever you notice groups of crows in your neighborhood, please let me know. The odds are good that such groups or individuals will return to the same areas numerous times. These individual crows and small groups (about 3 to 8 birds) intrigue me most, especially their aggressive behaviors toward each other.

Crows are usually interesting to watch, but be mindful that any crow you see is seldom just sitting there doing nothing, although it may appear that way. Observe patiently and you will notice behaviors that often escape the casual viewer. The scientific literature is replete with accounts of Corvid intelligence and their complex social activity.

I would be pleased to hear of any observations you wish to report, such as hiding food, stealing objects, teasing animals, or who knows what else! For example, once a group of crows near my house was snatching pecans from a yard, carrying them to another tree about 100 yards away, and then dropping them on the street below so passing cars could smash the nuts for them! Certainly many of you also have crow stories to tell. If you start paying close attention to these amazing birds, you will soon have plenty of remarkable observations to pass along.

Crows, Ravens, and Jays have fascinated me for a long time. I doubt that my interests will soon change, because there are many new things to learn about the crow family. LOS PADILLAS WILDLIFE SANCTUARY ---Dolores Varela-Phillips

Los Padillas Elementary school in the South Valley has four acres in marginal river bosque vegetation which is called the "Los Padillas Wildlife Sanctuary". The goal for this area is to have it become an environmental classroom. outdoor The Ecology Committee of Los Padillas Elementary school has spent the last two school years establishing a philosophy of use, compiling an activity book around identified study areas, working with resource people to help plan the use of the Sanctuary, and soliciting proposal writing assistance.

The goal for the 89-90 school year is to have teachers start using this outdoor classroom. The most expedient way to make this happen is to engage the help of one or more volunteer docents who would work with the teachers 2 or 3 days a week this fall. The teachers would like for the docents to come up with an introductory interpretive program and model for enthusiastic teachers ways in which use of the Sanctuary could be incorporated into their classroom curriculum.


CONSERVATION NOTES BY LEW HELM

AMERICAN HERITAGE TRUST ACT

Over the years, the Land and Water Conservation Fund has been accumulating funds supposed to be earmarked for acquisition of parks, wildlife areas, and other open space. However, the past Federal Administration, continued by the present administration, has spend only about \$200 million out of about \$1 billion a year income from offshore oil drilling leases and royalties. The balance of the income has gone into the general treasury and spent for goodness only knows what.

Congressman Morris Udall of Arizona is sponsoring a bill in Congress which would require the revenues to go into a dedicated trust fund and the interest from such a fund would be used for land purchases. The bill has created quite a controversy. Chief among the opposition is the American Farm Bureau Federation, which fears that local, state, and federal agencies would have too much money to make large-scale land purchases. Our own Secretary of the Interior, Manual Lujan, has come out against the bill.

With wildlife habitat and other open space being lost at a prodigious rate, this bill makes sense to most of the conservation community. What change has the bill to pass congress and be signed by the President? We really don't know, but the critical time is upon us. Please write to our Congressmen and Senators and even to Secretary Lujan supporting passage of the bill.





MEXICAN WOLF REINTRODUCTION UPDATE

We wish there were as many Mexican wolves running wild as there are (or were) black bears in the Sandias! With help from the conservation community, it is possible that could come about. The New Mexico Wolf Coalition, of which the Audubon Society is a part, continues to be active in promoting reintroduction of the lobo. Recently, even the New Mexico Secretary of State, Rebecca Vigil-Giron, has voiced support for the reintroduction. We salute her and continue to support the Coalition. Among several alternatives, the best site for releases is the White Sands Missile Range in southern New Mexico. Stock for the reintroduction is available in several zoos, including the Rio Grande zoo, but time is running out to have a viable wild stock available for release. The main opposition to the use of White Sands is the Commanding Officer of the Missile Range. He is concerned that there would be too many people involved in the release and monitoring of the wolves, once they are established. We say that this is a poor excuse, since the Army would have complete control of the minimal comings and goings of research personnel.

ACID RAIN PROBLEMS IN THE WEST

Most of us know that acid rain is damaging wildlife habitat, timber stands. waterways, buildings. and historical monuments in the United States and Canada. So far, we in the Southwest have thanked our lucky stars that the real problem areas seem to be in the Northeastern U.S. and in Canada. However, there is reason not to be complacent, even in New Mexico. Data collected in 1984 show that of the U. S. annual total of about 22.5 million tons of sulphur dioxide emissions, almost 1 million tons are emitted annually in Arizona and New Mexico. No doubt emissions today are significantly higher than in 1984.

We know the main culprits of sulphur dioxide are power plants which burn coal. Recently, there has been much concern about the haze which is destroying views in the Grand Canyon area. Most of the haze has been attributed to the Navajo

Power Plant in Arizona. This plant is 25% owned by the U. S. Government through the Bureau of Reclamation. Lesser amounts of the haze have been traced to sources in California. You can rest assured that where there is a power plant inducing haze, acid rain effects are accumulating. We hope the present federal administration will come to grips with the problem in the Southwest. One of the first things which should be done is to require the use of scrubbers in the Navajo Power Plant. If you care, write to Secretary of the Interior, Manual Lujan. With new risks coming every day, we cannot afford to wait any longer.



FIELD TRIPS: MANZANO MOUNTAINS HAWK MIGRATION

In case you are unable to attend the CNMAS field trip on Sunday, October 8th, to the Manzanos, you can still participate in the raptor counts.

The Western Foundation for Raptor Conservation is sponsoring a series of weekend field trips throughout September and October 1989. Participants will learn from an expert how to identify raptors. Dates of remaining trips are October 7, 14 and 15.

Meet a field trip leader at 10:00 a.m. in the town of Manzano and carpool 9 miles on a dirt road to the top of the Manzano Mountains. A brief lecture on the history and results of the project will be given. Bring binoculars, bird book, sturdy footware. windbreaker, jackets and sweaters (you will be at 9,000 feet elevation), water, and a lunch (optional). A donation of \$15 from each participant (or \$20 includes a box lunch) is requested by the Foundation. Each trip is limited to 15 persons.
